I would like to take a moment to thank all of the Trustees and committee chairs for the great job they do. They spend countless hours planning and managing the everyday responsibilities of the association. Often, this goes unnoticed. A special thanks again to the road committee and to Jeff Gross, who is committed to the job of keeping our roads clear during the winter months. We had some hiccups in service this year, that will need to be discussed during the upcoming bid process. The current service provider fell seriously ill, and his replacements were unaware of the finer details involved in the plowing of the peninsula. But we made it through, under budget again this year!

I would like everyone to know, that the Board can't do everything. We need the support of the entire membership to help keep the Peninsula a safe and beautiful place to live. It may be as simple as paying your dues on time. Driving and obeying the speed limits, obtaining the proper permits prior to building. Other simple things that help include, cleaning and maintaining your road frontage. Consumers Power did extensive tree trimming this winter. *(I think it was only 8 days before our next power outage!)* That wooded debris is your responsibility. Stack it, burn it, or give it away, several members heat with wood. Sweep and or blow your road frontage clean of loose material. Avoid storing unused equipment in plain site, get rid of your junk! Bring in your trash container after service day ***(by the way, have you switched to Ilpa's preferred service provider American Waste yet....see info attached or go on web site for details)***. All of these little things go a long way in keeping our Peninsula a safe and beautiful place.

A few quick reminders to help allow everyone enjoy the coming months of summer on Long Lake Peninsula.

**BOAT LAUNCH/BEACH USE:** The new dock has been installed with thanks to a large volunteer force. Come on down and experience the new, and safer version of docking. There is a 10 x 12 viewing area at the end which is intended for parents or guardians to view younger swimmers. It is not intended for sunbathing. Please keep the dock clear for easy ingress and egress. There are no coolers or glass containers allowed at the boat launch area. Broken glass had caused serious injury last year to a visitor.....please be considerate.

Please have your boat ready for the water. Take the time to prep your boat and make sure it runs. If a problem does present itself, there is an area for a single boat to be pulled up South of the launch for troubleshooting. Please be considerate of others trying to launch their crafts when busy. If your boat has been in lakes where zebra mussels are present.....scrub and wash your hull off prior to using any launch on Long Lake.

There is limited parking available at the launch. There is no parking on LLPA roads. NO BOATS ARE ALLOWED IN THE SWIMMING AREA, which is the area directly north of the LLPA dock, extending out to and just beyond the raft. All pets must be leashed and owners are required to clean up after their pets.

Again, letters have gone out to approximately a dozen or so members, who are in arrears with their LLPA dues. The park, boat launch and beach area is for the benefit of members and guest of LLPA. You should note that, according to our bylaws, Art. XIII, Sec. 3. F. a. "The boat ramp and beach area shall be used exclusively by members of the Corporation who are **in good standing**, their immediate families, and household guests". (Emphasis added) Thus, **you must be current with your dues in order to use the park, beach and boat ramp**. Please contact Jim McCall (929-0425), the association treasurer, with questions or to make arrangements to become current.
